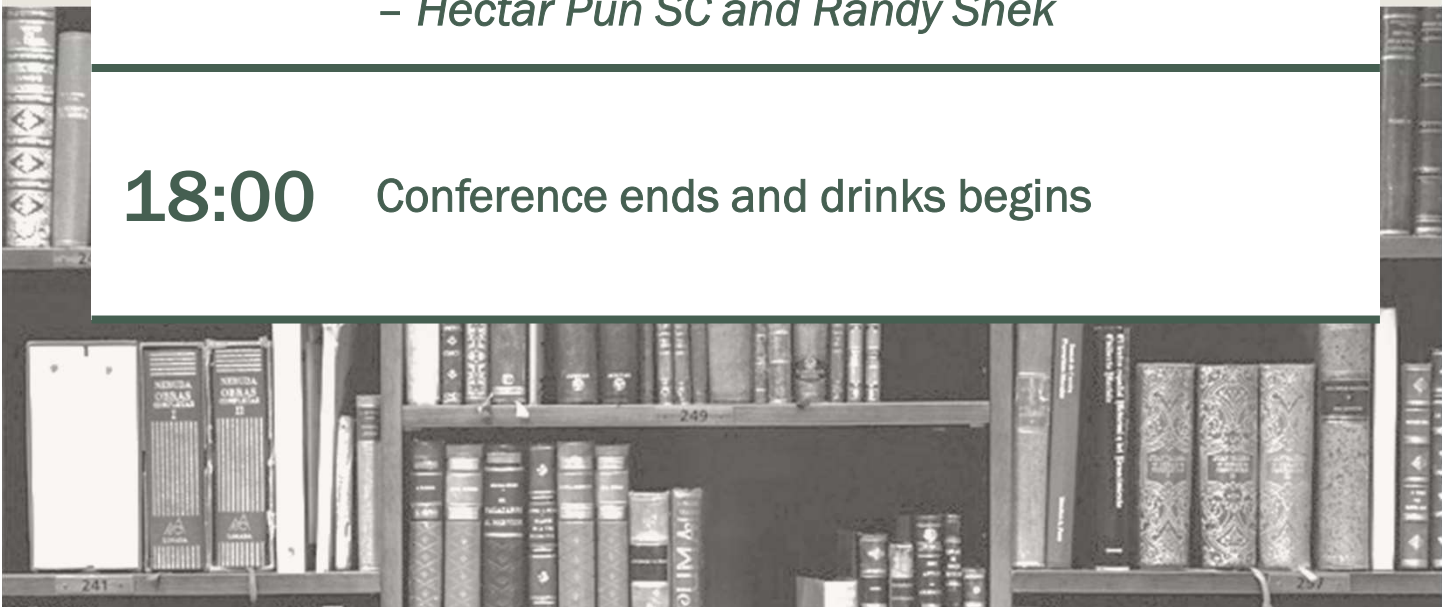

## Paul Harris SC, Denis Chang's Chambers and Doughty Street Chambers

Paul Harris SC is a public law and human rights specialist but also has considerable experience of property and commercial litigation including issues relating to trusts. He has considerable experiences of cases involving issues of cross-border jurisdiction and is the joint author of Johnston & Harris: "The Conflict of Laws in Hong Kong" (Sweet & Maxwell 2017). He practices in both London and in Hong Kong, where he is one of the SAR's leading public law silks.



## Hectar Pun SC, Denis Chang's Chambers

Hectar was called to the Bar in 1995 and appointed Senior Counsel in 2015. Hectar's practice spans many areas including constitutional and administrative law, human rights law, immigration law, land law, company law and commercial law. He appears regularly on behalf of applicants in major judicial review proceedings. Hectar has acted for the Catholic Diocese of Hong Kong, legislative councillors, district councillors, demonstrators, police officers, prisoners, refugees and asylum seekers, tenants of public housing estates, homosexuals, transsexuals, the disabled and the underprivileged, etc.



## Randy Shek, Denis Chang's Chambers

Randy's main areas of practice include criminal law, human rights and civil liberties, and public law. He is mainly a criminal defence counsel. He has a long and established track record for defending cases arising from protests, demonstrations and other high profile public order events, which frequently involve human rights and civil liberties dimensions. Randy's recent notable cases include acting for Joshua Wong in the Civic Square unlawful assembly case, successfully defended in a Mong Kok Riot case, and the National Independent Party conspiracy to manufacture explosives case.

## Edward Fitzgerald CBE QC, Doughty Street Chambers

Edward Fitzgerald QC has been named Human Rights and Public Law Silk of the Year (Chambers Bar Awards 2013). Previous commendations include Legal Aid Lawyer of the year 2009, winner of the Silk of the Year award 2005 and Times Justice Human Rights Award 1998. He specialises in criminal law, public law, judicial review and international human rights law. In June 2008 he was awarded the CBE for services to human rights.

Edward is ranked 1st in Extradition in Chambers and Partners 2017, as a 'starred individual' in the area of Crime in 2018, and has been described as "a true intellectual giant – a top-class extradition and appellate lawyer", a "king of the field" and "a Rolls Royce in the cab-rank of barristers".
