To avoid any embarrassment, please ensure that your guests have their vaccination record on hand in either digital or printed form so that our staff can scan their QR code by the government mandated record system when entering the individual outlets. This also applies to children older than 12 as explained above. Guests who are not in possession of the necessary vaccination documents will not be able to enter the Club. Also, upon entering your function room, you and your guests must scan the "LeaveHomeSafe" 1/F QR code using the "LeaveHomeSafe" mobile app. This is a **mandatory** requirement by the government for all zones operating under Group D operation regulations.*
