BIOGRAPHY

Civil Practice

Stephanie accepts instructions in a wide variety of civil cases, involving personal injuries and employee compensation, probate, land and building management disputes, matrimonial cases involving child custody and ancillary matters, defamation and general contract, commercial matters. She has also acted as a junior counsel in appeals to the Court of Appeal and regularly accepts instructions for general civil, commercial, company matters, and in petition proceedings involving the Securities and Futures Commission. She also acts as a general mediator for all types of civil cases.

Personal Injuries

Stephanie is regularly instructed as counsel for both plaintiffs and defendants on personal injury claims for trials and drafting of advices. She also appears for clients on Legal Aid and those requiring Legal Aid appeals for intended common law personal injury claims. She has been involved in hearings for Employees Compensation Claims, and instructed in personal injury trials on liability and quantum. Stephanie has experience in disciplinary hearings of the Medical Council of Hong Kong, and has developed a special interest in medical negligence claims. She is on the Legal Aid panel for the area of personal injuries and is instructed regularly for PI cases by the Legal Aid Department. Stephanie also frequently acts as a mediator for settlement of personal injuries claims.

Land Law

Stephanie has been instructed as counsel in Legal Aid appeals involving environmental, town planning and land law, and has been involved in appeals against the Town Planning Board, adverse possession trials, judicial reviews involving land and environmental law, conveyance and property cases, as well as building management cases involving incorporated owners and private property owners. She has also been instructed for trials against the Planning Department and been advising counsel for cases involving conservation policies of New Territories land in Hong Kong. She also has experience in trials at the Lands Tribunal and is regularly instructed as mediator for lands and building management cases.

Matrimonial Law

Throughout her pupillage and into her own practice, Stephanie has accepted instructions in matrimonial cases involving child custody and ancillary matters which include the drafting of advices, affirmations and pleadings. She has also been involved in assisting her pupil master for High Court appeals and Family Court hearings on matrimonial cases, and has been accredited as a family mediator in Hong Kong after completion of over 60 hours of family mediation training by the Hong Kong Family Welfare Association and relevant supervised live-case assessments. She has been an HKMAAL accredited as a Family Mediator since 2024.

Criminal Practice

Stephanie conducts trials on fiat as Prosecutor for the Department of Justice and appears as Duty Lawyer in the Magistracies on a regular basis. She has been instructed privately as counsel for defendants at the Magistracies, District Court and appeals to the Court of Final Appeal, as well as in cases involving prosecutions from the ICAC and Planning Department.
